Gentlemen;

Reference is made to your application dated November 12, 1959, for permission to flare or vent low pressure casinghead gas produced from your Ohio-Federal Well No. 1, located in the SW/4 SE/4 of Section 24, Township 9 South, Range 37 East, Lea County, New Mexico, in the Sawyer San Andres Gas Poel. Administrative Order NFO-451 was issued by the Commission November 29, 1959, authorizing the flaring or venting of gas produced from the subject well until February 29, 1960.

We have reviewed your application and the administrative order entered in connection therewith and are now of the opinion that the period of time in which you were authorized to flare gas is probably unreasonably short.

We are, therefore, hereby rescinding Order NFO 451 dated November 29, 1959, and substituting for it this order.

By the authority granted me under the provisions of Rule 4 of Order R-1517 you are hereby authorized to flare gas from the abovedescribed well until November 29, 1960, provided that the gas-oil ratio remains 2000 to 1 or less.
