FULL DETAILS OF PROPOSED PLAN OF WORK

(FOLLOW INSTRUCTIONS IN THE RULES AND REGULATIONS)

We propose to do the following:

1. Pull rods, pump & 2 7/8" tubing.
2. Perforate 5 1/2" casing from 11,440' - 11,454' & 11,468' - 11,488' w/2 jet shots per foot.
3. Run 2 7/8" tubing w/perforations above bull plugged hookwall packer.
4. Set Packer @ 11,495' + and swab test.
5. If warranted, treat w/5000 gallons 5% NE acid.
6. Swab test.
7. If well will not flow, pull 2 7/8" tubing & packer.
8. Rerun 2 7/8" tubing, rods & pump.
9. Place on production.
