We propose to do the following in working over subject well:

1. Set cast iron cement retainer at 11,400'.
2. Cement squeeze perforations from 11,430' to 11,450' with 100 sacks of neat cement.
3. Perforate 5-1/2 inch casing from 11,292' to 11,300' with two jets per foot.
4. Acidize with 1000 gallons of regular acid, if necessary.
5. Swab, test, and return to production.
