The above well was plugged and abandoned in the following manner:

- (1) Hole was loaded w/mud laden fluid.
- (2) 25 sack cement plug was set on bottom opposite Dev. Perfs. (12,004-12,082).
- (3) 5½" csg. was shot off @ 5200 and pulled, 15 sack cement plug was set @ 5175-5225. (25' above and 25' below csg. stub)
- (4) Set a 35 sack cement plug @ 4554-4274.
- (5) 8 5/8" csg. set @ 4414 w/1535 sacks and 13 3/8" csg. set @ 384 w/375 sacks was left in place.
- (6) A 10 sack cement plug was set @ 20 - surface w/a 4" marker extending 4' above ground level to designate a P & A location.
- (7) Location has been cleared of all equipment and debris, pits have been leveled and the cellar has been filled in a workman like manner.
- (8) This location is now ready for inspection.
