Drilled well to 4443'. Set 4423 ft. of 9 5/8" O.C. 36# & 40# J-55 casing at 4442' w/2000 sks. 4% Gel cement and 300 sks. neat cement. Cement circulated. Plug down at 3:30 p.m. - 4-16-54. Tested casing with 1200 lbs. pressure for 30 minutes. no decline in pressure. To commence drilling at 3:30 p.m. 4-16-54 to approximate depth of 12,500.
