1. Spot 25 sacks cement through tubing into 4-1/2" casing at 4680' - 4954'.
2. Part 4-1/2" casing between surface and 4000' and pull.
3. Place 25 sack plug at top of casing stub.
4. Place 25 sack plug at base of salt section.
5. Place 25 sack plug at top of salt section.
6. Place 25 sack plug at bottom of surface casing (376').
7. Place 10 sack plug at surface of ground.
