Well spudded February 13, 1964. Drilled to 233' RKB & ran 227' of 7", 23# J-55 Casing set @ 233' RKB. Cemented w/150 sax regular cement w/2% CC. Cement circulated, plug down @ 10:00 P.M. 2-13-64. Cold water test, after 18 hours, to 1000# for 45 mins., test okay. Well was drilled to 2705', but due to red bed caving, hole was lost @ 1050'. Well was plugged 2-21-64, after verbal approval given by Eric Engbrecht over telephone to Ralph N. Conley, as follows:

- 25 sax cement plug @ total depth.
- 25 sax plug @ base of 7" casing.
- 10 sax plug @ surface.

Pits have been filled and the location levelled, and cleared of junk.
