SPUD DATE: 3:15 p.m. 7-10-64. Drilled 12-1/4" hole to 265' in redbeds. Ran 8 jts of 8-5/8", 24# casing (252') set at 263'. Cemented with 200 sks Class "A" Cement with 2% CaCl. P-D at 8:30 p.m. Cement circulated. WOC - 12 hours. Tested casing to 1000# - held O. K.

CASING WAS CEMENTED WITH OPTION NO. 2 AS FOLLOWS:

1. Volume of cement slurry - 210 cubic feet.
2. Dowell Class "A" Cement with 2% CaCl.
3. Approximate temperature of slurry - 80°.
4. Estimated minimum formation temperature - 80°.
5. Estimate of cement strength at time of testing - 1020# per sq inch.
6. Actual time cement in place prior to starting cement test - 12 hours.
