SPUD DATE: May 23, 1964, 4:30 p.m. Drilled 12- $\frac{1}{4}$ " hole to 265' in redbed. Ran 8 jts 8-5/8" (250') casing set at 263' with 175 sks Class "A" Cement with 2% CaCl. Cement circulated. P-D at 11:15 p.m. WOC - 18-3/4 hours. Cemented by Dowell. Casing tested with 1000# - held O. K.

CASING WAS CEMENTED WITH OPTION NO. 2 AS FOLLOWS:

1. Volume of cement slurry - 210 cubic feet.
2. Dowell Class "A" Cement with 2% CaCl.
3. Approximate temperature of slurry - 95°.
4. Estimated minimum formation temperature - 80°.
5. Estimate of cement strength at time of testing - 1020# per sq inch.
6. Actual time cement in place, prior to starting cement test - 18-3/4 hours.


