Excessive and foreign water is expected out of San Andres zone. We propose to rig up pulling, establish injection rate in the San Andres - if injectivity established, will squeeze with 100-150 SXS. of class "C" cement. Drill out and clean out to TD and return well to production either with a pumping unit or a progressive cavity pump. Expected to start work 1st of September, 1994.
