Set cast iron bridge plug at 9500' and capped with 2 sacks cement. Perforated 9336-38; 9352-54; 9372-74 and acidized with 1250 gallons regular acid. Pumped 735 bbls water per day. Squeezed perforations 9336-74 with 100 sacks. Drilled out cement and perforated 9467-68; 9479-80; 9127-29, acidized 9467-80 with 1500 gallons regular acid and perms 9127-29 with 1500 gallons acid.
