6. Propose to spot a 25 sx cement plug at 8-5/8 casing stub at 2000'.
7. Propose to spot a 25 sx cement plug at 13-3/8 casing shoe at 301'.
8. Propose to spot a 10 sx cement plug at surface with marker.
9. Hole will be loaded with mud-laden fluids.
