Drilled to 4559', 3-16-61. Ran 101 joints 8 5/8", 24 & 32#, J-55, casing to 4175'. Cemented by Halliburton 2-plug method with 2200 sacks Lite-Wate with 1/4# floccle per sack and 12 1/2# gilsonite per sack followed by 200 sacks Trinity regular with 2% gel. Cement circulated. W.O.C. 48 hours. Tested casing with 1000# for 30 minutes, held OK.


