4/2/02 - Tagged fish with overshot, released packer and TOH with tbg and packer.

Decision made to plug well rather than repair. Plugging instructions received verbally from Gary Wink with NMOCD.

4/3/02 - Set CIBP at 10,290', capped with 35' cement.

4/4/02 - TIH with chemical cutter. Spear 4-1/2" casing. Cut casing at 9850'. Pulled 120,000#, casing did not move. Decision to consider completion in San Andres instead of plugging. Wait on decision.

4/8/02 - Shut well in, rig down and move off.
