Well is currently in the Austin (Mississippian) Field producing from perfs 13,199-13,464'. Market curtailment reduced production to 51.5 mcf/day during the first 11 months of 1984. This is less than half of deliverability. We wish to temporarily abandon the Mississippian to test the Cisco at a depth of 11,176-11,224'. The zone produced oil with water on drill stem test. A 6" 900 manual BOP will be used.
