Drilled to a total depth of 4,090'. On 1-19-84, ran 8 5/8" 32# J-55 casing and set at 4086'. Cemented with 1250 sx class C Lite with additives and tail in 400 sx Class C Neat. Circulated out 393 sx. WOC 18 hrs. Pressure tested casing 1000 psi for 30 mins. Held OK. Reduced bit to 7 7/8" and resumed drilling.
