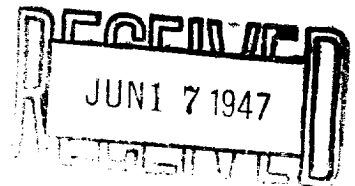

5/29 Started moving out light rotary. Moving in and rigging up spudder to complete well. Drilled out cement plug June 9th and tested one hour for shutoff. Well tested dry. Drilling ahead with cable tools.
