Set 8-5/8" Casing in this well at 3495' and cemented with 1000 sks 8% Gel cement, with 50 sks Strata-Crete, and 200 sks neat cement. Plug down at 8:35 PM 8-21-54. Top of cement behind 8-5/8" casing is 590' down from surface. Tested casing with 1000 psi for 30 minutes, held OK.
