Spud well on November 2, 1984. Drill 17" hole to 432'. Ran 432' of 13 3/8", 61# K-55 casing. Cemented w/ 450 sxs Class C w/ 2% CaCl₂. Circulated 100 sxs. WOC 18 hours. Tested to 1000# for 15 minutes, test okay. Resume drilling a 11" hole to 4838'. Ran 4838', 24 & 32# J-55, and 28# S-80 8 5/8" casing. Cemented w/ 1900 sxs Halliburton Lite containing 15# salt, 5# gilsonite and 1/4# flocele. Tailed by 200 sxs Class C. Circulated 200 sxs. WOC 18 hours. Tested to 1000# for 30 minutes, test okay. Resume drilling a 7 7/8" hole.
