FULL DETAILS OF PROPOSED PLAN OF WORK
(FOLLOW INSTRUCTIONS IN THE RULES AND REGULATIONS)

To increase production we propose to do the following work:

1. Pump well down and inject mixture of 55 gals. of cheplex and 500 gals of 5 per cent hydrachloric acid down tubing casing annulus.
2. After a period of 24 hrs, pull rods and tubing.
3. Fracture open hole section 4346' to 4710', down 3" tubing with hookall packer set at 4300', in three stages each of 10,000 gals of refined oil carrying one pound of sand per gal with 1,000 lbs of flaked naphthalene between stages.
4. Recover load oil, test, and return well to production.
