Cactus Drilling Co. spudded 17-1/2" hole at 3:00 PM on 11-5-62. On 11-6-62, 13-3/8" OD 35.6# SJ casing was run and set at 330' with 320 sx cement, circulated 15 sx cement. After WOC 18 hours tested casing with 600 PSI for 30 minutes with no loss in pressure. Reduced hole to 11" at 330' and resumed drilling operations.
