Fowler Well No. 6 is completed at a total depth of 3235' in the Bowers Sand. It is proposed to deepen this well approximately 40' through the second pay zone in the Bowers Sand and sand fracture with 20,000 gallon of lease oil and 30,000 pound of sand. This well is currently producing 6 barrel of oil and no water. Based on results obtained from fracturing Fowler Wells No. 7 and 8, it is believed that this well will produce top allowable after workover.
