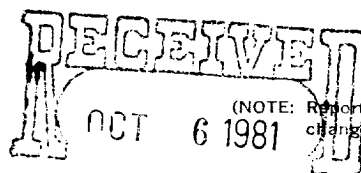

Moved in service unit (X-Pert #21) on 9-17-81. Pulled tubing and packer. Set cast iron bridge plug at 13000' and capped with 50' cement. Perforated intervals 10887-91 and 10914'-26' with 2 JSPF. Ran tailpipe and packer back in hole. Set tailpipe at 10832 and packer at 10768. Swabbed 3 hrs. and recovered 32 BLW, no oil, and no show of gas. Currently preparing to acidize.
