Cement 2nd stage casing 978 sx 35/65 Poz "C" + additives and 200 sx "C" + additives. Did not circ 2nd stage, pumped 420 sx Class "C" + additives with 1" tbg. Circ 10 sx cmt to surface. WOC 24 hrs. Cut off casing and weld on wellhead. NU BOPE and test.
