1. State of New York, County of Westchester, ss. I, John J. Sullivan, Clerk of the said County, do hereby certify that the foregoing is a true and correct copy of the original of the same as the same appears from the records of the said County.

Subject well was drilled to 8672 to complete in the Bone Springs with 4½" 10.6 and 10.50# set @ 8672 cemented with 250 sacks Hal-lite 450 sacks Class C- top of cement @ 5530'. Intermediate casing 32# to 24# set @ 4481 cemented with 2000 sacks Hal-lite, 300 sacks class C, 203 sacks circulated to pit. Surface casing 13 3/8" 54.50 # set @ 667' cemented with 759 sacks class C. 125 sacks circulated to pit.

Perforate 8493-99 8502-08 8511-18 4SPF. Treat with 5000 gallons SRA 20% acid. Recovered 100% formation water, set retainer @ 8450 squeeze with 100 sacks of class H cement. Perforate 8414-34 with 2SPF recovered 490 barrels of oil. Treat zone with 5000 gallons of SRA acid. Zone depleted. Drill out retainer and cement to 8502. Acidized 8493-8502 with 1500 gallons 15% HCL. Recovered 100% formation water. PPTD 8502.

Proposed plugging program--Pump 25 sacks--plug 8502-8302- cut 4½" casing @ approximately 5400'-set 45 sacks, plug 5475-5325. Set 45 sacks plug--4556--406. Set 30 sacks plug--717-617'. Set 10 sacks plug @ surface. Cement used for plugs will be Class C.
