
DETAILED ACCOUNT OF WORK DONE AND RESULTS OBTAINED

Ran 89 Jts (3712') 7" OD 20# Gr J-55 SS casing. Set and cemented at 3725' with 1750 sacks 4% Gel and 150 sacks Neat cement. Plug at 3680'. Maximum pressure 1500#. Circulated approximately 50 sacks cement. Job complete 9PM 2-21-55.

After waiting over 30 hours, tested 7" casing with 1000# for 30 minutes. There was no drop in pressure. Drilled cement plug from 3680' to 3725'. Tested below casing shoe with 800# for 30 minutes. No drop in pressure.
