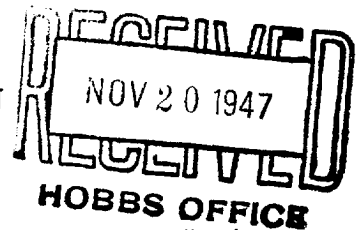

FOLLOW INSTRUCTIONS IN THE RULES AND REGULATIONS OF THE COMMISSION

On November 20, 1947 at 4:45 A.M., 48 hours will have elapsed since running 1410' 9-5/8" OD Casing in subject well and cementing with 700 sacks to be used as intermediate string. At this time casing shut off will be tested in the following manner:

A Pressure of 1000# will be built up and held for 30 minutes and if test is o.k., cement plug will be drilled and a pressure of 1000# again built up and held for 30 minutes. If this test, too, is o.k., drilling operations will be resumed.
