Stanford #3 was sand-oil frac-ed down 3" tubing from 3725' to 3922' in open hole, packer set at 3680' Used 500 bbls of treated oil and 350 bbls of lease crude with 18000lbs of sand (20-40) and 2000 lbs of walnut hulls.

Pressures recorded were 3800# on 3" tubing and 1000# on casing. Injection rate a verage 15bbl a minute. Shut in pressure 2750#
