1. Pull R.B.P. at 3504'.
2. Set a C.I.B.P. at 4450'. Spot 35' cement on top of C.I.B.P.
3. Circulate hole with mud.
4. Spot 25 sxs cement 3850-4020'.
5. Spot 25 sxs cement 2000-2125'.
6. Perforate 7 5/8" casing at 300'.
7. Circulate 120 sxs cement to fill 7 5/8" and 7 5/8" x 10 3/4" annulus to 300' *to surface*
8. Install dryhole marker and clean location.
