> Re: Application for Exception to Order No. R-553 As It Applies to Flaring of Gas in The Atlantic Refining Company's State "AN" Lease, Jalmat Pool, Lea County, New Mexico

Gentlemen:

Application is herewith submitted for administrative approval for the temporary flaring of gas produced by The Atlantic Refining Company's State "AN" No. 1 well, located in the NE/4 of the SE/4 of Section 23, T-22-S, R-35-E, Lea County, New Mexico. In conjunction with this application the following information is presented:

- 1. The Atlantic Refining Company is the operator of the State "AN" No. 1 well which is completed within the vertical limits of the Yates formation and located in the Jalmat Pool cr within one mile of the horizontal limits of the Jalmat Pool.
- 2. The latest available gas-oil ratio test taken on this well on March 6, 1957 indicates that it is capable of producing 13.78 BOPD from the Jalmat Pool, and that its GOR is 976 standard cubic feet of gas per barrel of oil. Based on this production, approximately 13.5 MCF of gas per day will be flared from this well.
- 3. Negotiations are presently underway between the Phillips Petroleum Company and The Atlantic Refining Company relative to the sale of this and other gas in the area. Because their present line in the area is gathering gas at its capacity, Phillips is studying the economics of looping it; however, they have not finished this study and therefore cannot set a data for connection.

- The Atlantic Refining Company has filed Form C-110 for this **L**₀ well showing the present disposition of the gas and after connection they will file such form again.
- Atlantic's State "AN" No. 1 will is capable of producing 5. 13.78 BOPD from the Jalmat Pool, and if closed in to prevent flaring of gas it will fail to recover all recoverable oil from its proration unit. It is Atlantic's opinion that correlative rights and the best interests of conservation will not be protected if this well does not produce.
