FULL DETAILS OF PROPOSED PLAN OF WORK

We propose to convert this well to water injection service to expand the water flood project now in operation under authority of Commission Order R-2495 and WFX-180.

This well will be cleaned out to TD and 2" FUL 1.7" J-55 tubing run on packer and seated at approximately 3000' (1000'+ below top of cement) Injection will be through 2" tubing with the annular space between tubing and casing loaded with inhibited water.

This well is offset to the north and diagonally northwest by wells which have experienced increased production due to the existing water flood project.
