Basic well data: TD 3850; 5 1/2" casing cemented @ 3844 (2-stage: 300 sx around shoe and 150 sx thru DV tool @ 1640'); PBTD 3842'. Initial completion as oil well March 1, 1957. Casing perforated: 3614-3644 (Yates Zone I) 4 SPF; 3660-3666 (Yates Zone II) 4 spf; 3768 and 3774 (Yates Zone IV) 3 FI holes at each spot; and, 3800 (Yates Zone V) 3 FI holes.

Work-over to open Yates Zone III and selectively frac same. WO dates 5/30-6/22/67.

Pulled rods, pump and tubing. Schlumberger jet perforated with one 3/8" hole each at 3717, 3725 and 3732' opposite Yates Zone III. Ran Baker ret BP to 3738; set FB pkr at 3683'. Frac'd new Zone III perfs via 2-7/8" tubing with 3,000 gal. gelled, treated brine plus 2000 lb 20/40 sd and 2000 lb 10/20 sd. AIR 7 BPM at 2200 psig. ISDP 1000 psig; well on vacuum in 20 minutes. Pulled packers. Ran 2-3/8" open-end tubing to 3801'. Top tubing tension anchor and bottom seating nipple at 3604'. Ran 2"x1 1/2"x12' BHD T/B pump on full 3/4" rod string. Recovered all load. Then on 19-hour test June 22-23, 1967, pumped 51 BO + 67 BW.

Basic well data: TD 3850'; 5-1/2" 14 lb casing cemented at 3844' with 300 sacks on bottom and 150 sacks through Halliburton DC tool at 1640'; casing perforated 3614-3644, 3660-3666 with 4 SPF, and at 3768, 3774 and 3800'; top Yates 3608'.

Set Bethlehem 57 DA beam pumping unit with 10 HP electric motor on precast concrete base. Tagged bottom with tubing at 3725'. Cleaned out sand to 3755'. Drilled bridge plug at 3755' Cleaned out to 3825'. Ran 2-3/8" EUE tubing to 3777'. Notched collar on bottom. Seating nipple at 3592'. Ran 2" x 1-1/2" x 12' BHD pump on 94-5/8" rods and 48-3/4" rods. Kicked off pumping unit on 11.3 - 54" SPM May 4, 1965.

Above work performed between March 9 and May 4, 1965.
