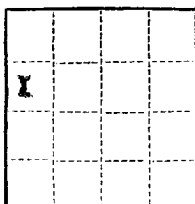

DETAILS OF WORK

The following casing pattern is planned: 8 5/8" OD set at 350' with 350 sacks, cement to circulate; 5 1/2" OD set at 3625' with approximately 1100 sacks, cement to return to 1600'.

Permission is requested to produce this well upon completion.
