The Eunice Oil Zone (O.H. 3746-3890') has been plugged and abandoned by setting a 5½" 17# CIBP @ 3700'. CIBP was capped w/5 sx cement (35'), new PBD = 3665'. Eunice Oil zone P & A 3/8/73. The Eumont Yates gas zone is now being produced through 2-7/8" tubing with production packer at 3371'. On 4/2/73 Eumont Yates zone (perfs 3414-3630') was producing at rate of 750 MCFGD.
