03/11/02 Pressure test casing to 500# for 30 minutes - OK. Hook well up to injection system and put on injection.

04/11/02 Pressure test casing and chart - OK. (See attached chart)

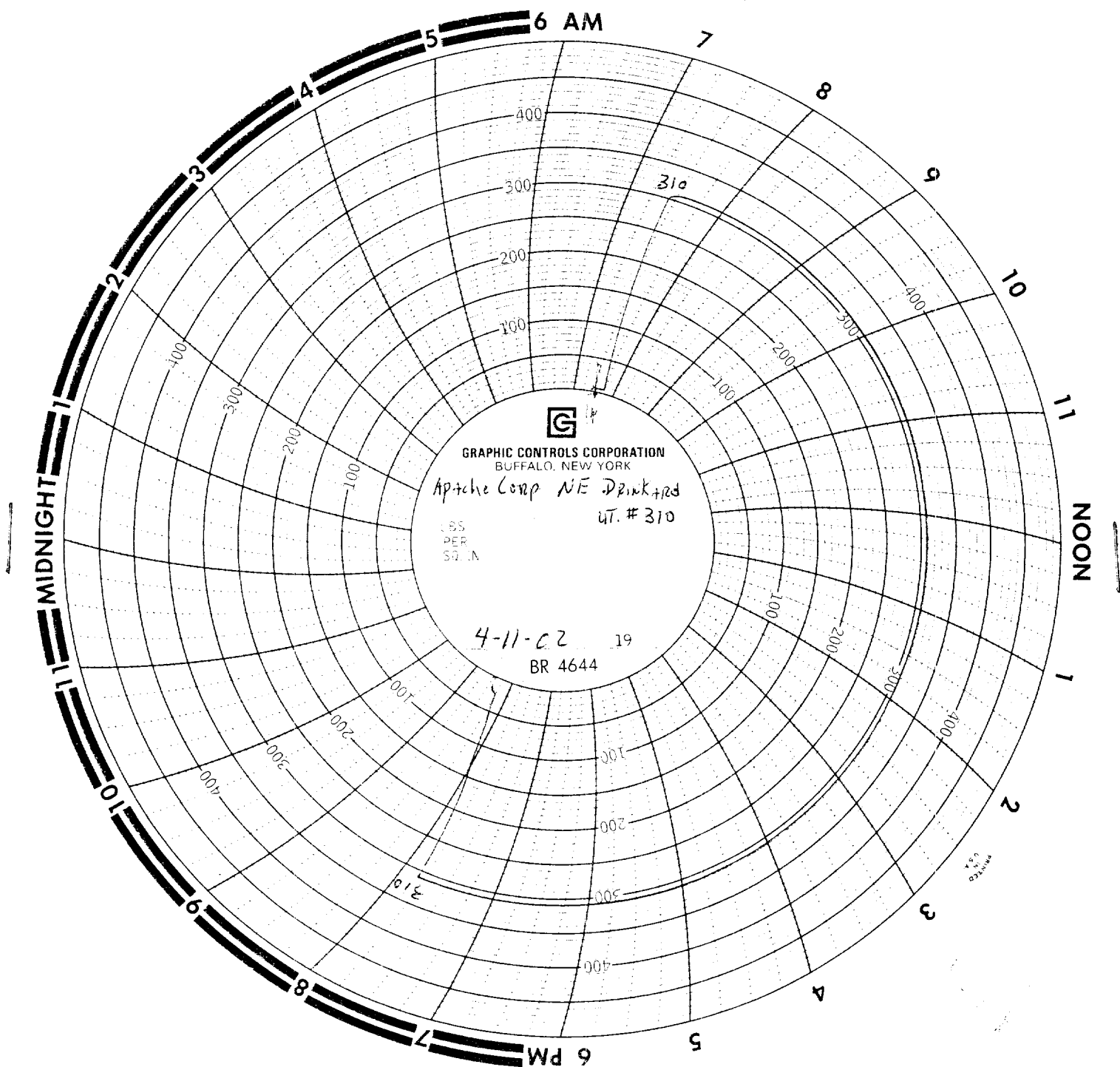
