Effective January 1, 1972, the following wells are hereby reclassified as gas wells in the Blinebry Pool:

This reclassification is necessitated by the fact that the wells are producing considerably in excess of the limiting ratio of 32,000 for the Blinebry Pool.

The wells are to be shut in on January 1, and will remain shut in until you have complied with the provisions of Commission Order No. R-1670, that portion which pertains to the Blinebry Gas Pool.
