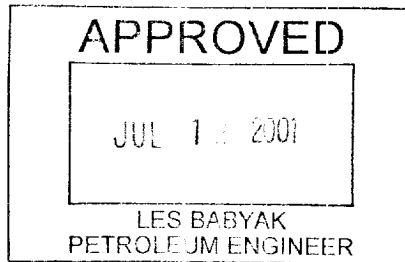

Apache proposes to re-activate TA'd well and recomplete in the Penrose Skelly; Grayburg pool:

- 1.) Drill out CIBP @ 2950'
- 2.) Cement squeeze perforations 3000' - 3770'
- 3.) Test Cement squeeze
- 4.) Perforate Grayburg approximately 3800' - 4000' (perforations to be determined by log)
- 5.) Acidize and Fracture treat Grayburg perforations
- 6.) Return well to production as Grayburg producer
