GENTLEMEN :

THE DIRECTOR'S MEMORANDUM DATED DECEMBER 15, 1989 GRANTED A MORATORIUM FROM SHUT-IN OF OVERPRODUCED WELLS UNTIL MARCH 15, 1990. THAT PERIOD IS OVER AND ALL EXCESSIVELY OVERPRODUCED WELLS ARE TO BE SHUT-IN AFTER THAT DATE UNLESS WRITTEN AUTHORIZATION IS GIVEN TO PRODUCE AT A MINIMAL RATE TO PREVENT LEASE CANCELLATION .

YOU WILL RECALL THAT THE DECEMBER 15TH MEMORANDUM CAUTIONED THAT ALL EXCESSIVELY OVERPRODUCED WELLS ARE TO BE PRODUCED ONLY DURING, AND TO THE EXTENT NECESSARY TO MEET, THE EMERGENCY DEMAND. ABUSE OF THIS MORATORIUM BY ANY PRODUCER MAY NECESSITATE ACTION BY THE DIVISION IN ADDITION TO MERE SHUT-IN.

YOU ARE HEREBY ADVISED THAT AS OF FEBRUARY 28, 1989 THE FOLLOWING-DESCRIBED WELL WAS EXCESSIVELY OVERPRODUCED AS SHOWN AND SHOULD BE SHUT-IN APRIL 1TH UNLESS IT HAS BEEN BROUGHT INTO A CONDITION OF PERMISSIBLE OVERPRODUCTION BY CURTAILMENT OF PRODUCTION DURING FEBRUARY AND MARCH.
