DETAILED ACCOUNT OF WORK DONE AND RESULTS OBTAINED

Completed 8-1-52 after installing Reda pump. Reda equipment from bottom up as follows: 97.5 HP Reda motor, Reda type 44 series 540 protector, Reda type 42 series 540 auxiliary grease reservoir, then Reda type B-16 223 stage series 450-540 pump. Reda standing valve 1 jt above pump. Reda KO plug 2 jts above pump. Bottom of motor at 7830'. Pump intake at 7779'.

RESULTS: Initial pumped 608 oil 213 water thru 2-3/8" tubing in 24 hrs ending 1st. 24 hour gas volume 585,200 cu.ft. GOR 963/1. 90 Amps. TP 35# CP 35#. Allowable 101 bpd exempt. Daily average production before workover - dead. Allowable before workover - none.
