Pulled producing equipment. Set CI BP at 6340' and dumped 10' cement on top of BP, abandoning Drinkard open hole interval 6348' to 6463'. Calculated PB at 6330'. Perforated Drinkard zone in 7" casing with 2, .72" JHPF at 6322-24', 6282-84', 6260-62', 6229-31' and 6204-06'. Ran treating equipment. Treated new perforations with 2,000 gallons of 15% NE acid and frac treated with 35,000 gallons of 9.2# gel brine water containing 0 to 2% SPG. Flushed with 1600 gallons of gel water. Maximum pressure 5100#, minimum 4000#, ISIP 1900#, after 15 min 1300#. AIR 18.9 BPM. Pulled treating equipment. Ran Baker Model R packer on 2-3/8" tubing and set packer at 6130'. Closed well in pending gas contract negotiations.
