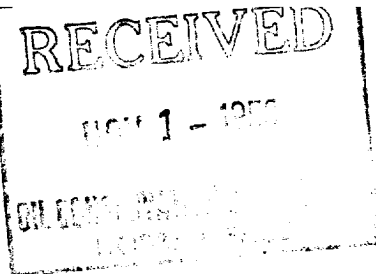


REPORT OF THE COMMISSIONER OF THE LAND OFFICE
