DETAILED ACCOUNT OF WORK DONE AND RESULTS OBTAINED

TD 3650 - set 9 5/8" CD casing @ 3650 and cemented with 3600 sacks cement. Halliburton unable to move pin in cementing head, left casing full of cement. Drilled cement to 3260, perforated 9 5/8" casing W/2 - 1/2" holes @ 1625, set Halliburton retainer @ 1586 and recemented with 1320 sacks cement. Ran temperature survey which indicated top of cement back of 9 5/8" casing @ 25 feet from surface. Let cement set 48 hours and tested with 1000# pump pressure for 1 hour before and after drilling cement plug. No decrease in pressure. Resumed drilling.
