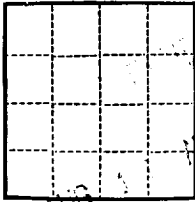

DETAILS OF WORK

It is proposed to drill with Rotary Tools to the Seven Rivers-Queen formation at about 3,500'. Set 4-5/8" casing at 300' with cement circulated. If productive set 5-1/2" casing to total depth and cement with about 250 sacks which gives a calculated fill-up of 1,691'.
