Application for 120-Acre NSP Unit - Continental Oil Company - Shahan 33
No. 1, Unit Letter A, Section 33, T-25S, R-37E, Lea County, New Mexico

Continental Oil Company respectfully requests the reassignment of acreage, currently dedicated to its Shahan 33 No. 3, to the subject well, Shahan 33 No. 1, located 990 feet from the north line and 660 feet from the east line of Section 33, T-21S, R-37E, Lea County, New Mexico. The proposed reassignment is for a 120-acre non-standard unit, which consists of the S/2 and the NE/4 of the NE/4 of Section 33, T-21S, R-37E, Lea County, New Mexico. Shahan 33 No. 3 is shut-in due to economical depletion, and there is presently no possibility of restoring it to production.

The proposed unit conforms to requirements as follows:

- (1) Said unit consists of contiguous quarter-quarter sections (and/or lots).
- (2) Said unit lies wholly within a single governmental section.
- (3) The entire proposed unit may be reasonably presumed to be productive of gas.
- (4) The length or width of said unit does not exceed 5,280 feet.
- (5) Copies of this application have been furnished by certified mail to all offset operators and all operators within said section.
