EOG Resources, Inc. (OGRID No. 7377) seeks administrative approval of an unorthodox well location for its **Dogwood 23 Fed Com No. 706H Well** (API No. 30-025-44097) to be completed within the Sanders Tank; Upper Wolfcamp (Pool Code 98097) underlying the W/2 E/2 of Section 14 and the W/2 E/2 of Section 23, Township 26 South, Range 33 East, N.M.P.M., Lea County, New Mexico. This well will be drilled from a surface location 194 feet from the south line and 2,387 feet from the west line (Unit N) of Section 23. The upper most perforation will be located 100 feet from the south line and 2,560 feet from the east line (Unit O) of Section 23 and the lower most perforation will be 100 feet from the north line and 2,560 feet from the east line (Unit B) of Section 14. Since this acreage is governed by the Division's statewide rules, the completed interval for this well will be unorthodox because it is closer than the standard offsets to the western boundary of the project area.

EOG is the 100% working interest owner in the E/2 W/2 of Section 14 and the E/2 W/2 of Section 23, and ownership is identical in said spacing unit to the proposed spacing unit. Approval of the unorthodox completed interval will allow EOG to use their preferred well spacing plan for horizontal wells in this area and thereby prevent waste.

Exhibit A is a Well Location and Acreage Dedication Plat (Form C-102), which shows that the completed interval of the proposed **Dogwood 23 Fed Com No. 706H Well** encroaches on the spacing and proration unit to the west.

Exhibit B is a land plat for Sections 14 and 23 and the surrounding sections that shows the proposed **Dogwood 23 Fed Com No. 706H Well** in relation to adjoining units and existing wells.
