Spur Energy Partners LLC respectfully requests administrative approval of a non-standard location on the Morris Boyd 11H, API Number 30-015-Pending, Property Code Pending. The 11H well is proposed to be completed in the N. Seven Rivers; Glorieta-Yeso pool, Pool Code 97565. The proposed wellbore is to be completed within 330’ feet of the W/2 of the W/2 of Section 26. The proposed interval is projected as follows:

Surface Hole – 943’ FSL 882’ FEL Unit P Sec 23 T19S R25E
First Take Point – 100’ FNL 1260’ FEL Unit A Sec 26 T19S R25E
Last Take Point – 100’ FSL 1260’ FEL Unit P Sec 26 T19S R25E
Bottom Hole – 50’ FSL 1260’ FEL Unit P Sec 26 T19S R25E

The adjoining units which the unorthodox location encroaches are located in T19S R25E, Section 26, Units B, G, J and O.




