EOG Resources, Inc. (OGRID No. 7377) seeks administrative approval of an unorthodox well location for its **Pegasus 3 Fed Com #506H well** (API No. 30-025-47247) to be completed within the Triste Draw; Bone Spring Pool [96603], underlying the E/2 of Section 3, Township 24 South, Range 32 East, and the E/2 of Section 34, Township 23 Range 32 East, N.M.P.M., Lea County, New Mexico.

This well is to be drilled and completed at a surface location 554 feet from the south line and 2,306 feet from the east line (Unit O) of Section 3. The first take point is located 100 feet from the south line and 2,590 feet from the east line (Unit O) of Section 3, and the last take point is located 100 feet from the north line and 2,590 feet from the east line (Unit B) of Section 34.

Since this acreage is governed by the Division’s statewide rules, the completed interval for this well will be unorthodox because it is closer than the standard offsets to the western boundary of the spacing unit. Approval of the unorthodox completed interval will allow EOG to use their preferred well spacing plan for horizontal wells in this area and thereby prevent waste.




