COG Operating LLC requests administrative approval of a non-standard location for the Kraken State Com 702H, API number 30-015-48099. The 702H well is proposed to be completed in the Purple Sage; Wolfcamp pool, Pool Code 98220. This pool has special pool rules specifying the completed interval must be located 330 feet from the exterior boundary of the applicable spacing unit.

Approval of the non-standard completed interval will allow for efficient spacing of horizontal wells and thereby prevent waste.

The proposed completed interval is projected as follows:

Surface Location –	600' FSL & 1030' FEL UL P Sec. 33-25S-28E Eddy County, NM
First Take Point -	10' FNL & 1218' FEL UL A Sec. 4-26S-28E
Last Take Point -	330' FSL & 1218' FEL UL P Sec. 16-26S-28E
Bottom Hole -	200' FSL & 1218' FEL UL P Sec. 16-25S-28E
Proposed Pool-	Purple Sage; Wolfcamp (Pool Code 98220)

This will be a horizontal **gas** completion.

The Horizontal Spacing Unit will be 960 acres, E/2 of Sec 4, E/2 of Sec 9, and E/2 of 16-26S-28E as shown on the enclosed C-102. **The HSU defining well is the Kraken State Com 702H.**
