Dear Mr. Lowe,

Pursuant to Division Rules 19.15.16.15(C)(6) and 19.15.15.13(C)-(D) NMAC, Longfellow Energy, L.P. ("Longfellow") requests administrative approval of a non-standard location for the above-referenced oil well in an approximately 480-acre spacing unit, more or less, as described more fully below.

The standard setback in the horizontal plane from any point in the completed interval to any outer boundary of the horizontal spacing unit is 330 feet for an oil well. 19.15.16.15(C)(1)(a) NMAC. The completed interval of the above-referenced well, however, will be 142 feet at its closest point from the southern boundary of the spacing unit. Longfellow is requesting approval to decrease the setback for the completed interval of the above-referenced well.

The proposed surface and bottom hole locations and first and last take points are as follows:

1. SHL: 1272' FSL and 415' FWL of Section 20-T17S-R28E
2. FTP: 155' FSL and 100' FEL of Section 19-T17S-R28E
3. LTP: 142' FSL and 2535' FEL of Section 24-T17S-R27E

4. BHL: 142' FSL and 2615' FEL of Section 24-T17S-R27E

It is Longfellow's responsibility as a prudent operator to maximize the recovery of oil and gas reserves left in the ground. Approval of the unorthodox completed interval will allow Longfellow to use its preferred well spacing plan for horizontal wells in this area and thereby maximize recovery and prevent waste.

Attached is the C-102 form and map indicating the offset tracts to assist the Division in its review of Longfellow's request. Longfellow has sent notice to all affected persons on the enclosed spreadsheet by certified mail, return receipt requested, with a copy of this request, the plat, and the C-102. The notice also informs the affected persons that, if they object to the aforementioned requests, they must file the objection in writing with the Division within 20 days from the date the Division receives this administrative approval request. I attach a sample of the notice letter and a spreadsheet with the types of interests and names of the affected parties, the location of each parties' interest, the date the letter was sent, and the mail tracking number for the mailings that went out today.




