Tap Rock Operating, LLC ("Tap Rock") (OGRID No. 372043) seeks administrative approval of an unorthodox well location for its **Apollo State Com #212H well** (API No. 30-025-48635) to be completed within the WC-025 G-09 S243310P: Upper Wolfcamp Pool (98135) underlying the 640 acre, more or less, spacing unit in the E/2 of Sections 16 and 21, Township 24 South, Range 33 East, N.M.P.M., Lea County, New Mexico.

This well has been drilled at the following location:

- Surface location: 881 feet from the south line and 2,135 feet from the west line (Unit) of Section 21; **Unit "O", corrected (09/20/21)**.
- Bottom hole location: 40 feet from the north line and 2,335 feet from the east line (Unit B) of Section 16;
- First take point: 100 feet from the south line and 2,289 feet from the east line (Unit N) of Section 21;
- Last take point: 100 feet from the north line and 2,330 feet from the east line (Unit B) of Section 16.

Since this acreage is governed by the Division's statewide rules, the completed interval for the **Apollo State Com #212H well** is unorthodox because the completed interval is closer than the standard offsets to the western boundary of the spacing unit. Approval of the unorthodox completed interval will allow Tap Rock to use optimal well spacing plan for horizontal wells in this area and thereby prevent waste.

Exhibit B is a land plat that shows the proposed **Apollo State Com #212H well** in relation to the adjoining spacing units to the west in the SE/4 SW/4 of Section 21.






Tap Rock Operating, LLC ("Tap Rock") is seeking administrative approval of an unorthodox well location ("NSL") for the Well, to be completed within the WC-025 G-09 S243310P; Upper Wolfcamp Pool, Pool Code 98135 (the "Pool") underlying the DSU. The Pool rules establish 330' setback requirements. While drilling the curve, there was a strong tendency in this formation for the bit to pull west, which caused the azimuth to be more northwest than planned. By the time the azimuth could be corrected, 162.5' of the planned completed lateral was closer than 330' (allowing for the 50' buffer) from the DSU boundary. It is Tap Rock's responsibility as a prudent operator to optimize production from the Pool. Completion in this portion of the lateral, and the administrative approval of this NSL, increases ultimate recovery of reserves and thereby prevents waste of natural resources. Please let me know if you need anything else.
